### New Registrant Database is now LIVE!

The College of Dietitians of Alberta has upgraded our registrant database and subsequent <u>Login for</u> <u>Regulated Members</u>. We are using the same software as before (Alinity) but a newer version which is more user-friendly, responsive (designed to adapt to the device used to access the site) and has more features for regulated members.

The College encourages all regulated members to access the new database now (prior to renewal) to review the information contained within the portal, complete any necessary Profile Updates if the information is inaccurate, or to contact the College office if there are any errors on your profile.

The College encourages all regulated members to review the <u>Guide for Using the Registrant</u> <u>Database</u>, which highlights key changes to the registrant database all regulated members should be aware of, when accessing the new database.

# **Registration Requirement for Cross-Border Dietetic Practice**

The College of Dietitians of Alberta has received questions regarding the registration requirements for cross-border dietetic practice.

Legislation of health care professions falls within the jurisdiction of the provinces. Each provincial dietetic regulator must conduct their own analysis of their legislation and determine whether registration is required for dietitians who provide crossborder dietetic services to clients in their respective provinces. Some provinces may require registration for interjurisdictional practice, while others may not. This is why dietitians may see regional differences for registration across the country.

In Alberta, the College's legislative authority is derived from the *Health Professions Act*, and the profession-specific legislation, the *Registered Dietitians and Registered Nutritionists Profession Regulation*. Within these Acts, the College has a clear mandate to protect the public and ensure that only regulated members use the protected titles and hold themselves out as a person authorized to practice dietetics in Alberta when providing services to people in Alberta. As per the *Health Professions Act*, the College requires registration for all dietitians who provide services to clients in Alberta, whether those dietitians are physically located in Alberta or not. This includes providing dietetic services to clients in Alberta through any virtual means (e.g. phone, online, etc.).

Dietitians registered in Alberta should check with the respective regulators where they are seeking to deliver dietetic services to ensure they are complying with their interjurisdictional registration requirements. ## Important Notice for Regulated Members:

The College reminds all Dietitians that as regulated professionals, you have a duty to update your profile <u>within 30 days</u> of any change in the information required for the College's Register. This includes changes to your legal name, contact information (phone and email), mailing address, and employment information. You may update your profile information online by logging onto the <u>Login for Regulated Members</u> to complete a Profile Update.

If any information found on the <u>Public Register</u> is inaccurate or incomplete, please contact the College office to request a correction.
